### **CIRCULAR**

Sub: Centrally Sponsored Scheme of Pre-Matric Scholarship for ST Students in class IXth & Xth for the Academiv year 2024-25.

The Directorate of Tribal Welfare is implementing the Scheme namely:

Centrally Sponsored Scheme of Pre Matric Scholarship for needy Scheduled Tribe students studying in class IXth & Xth.

The objective of the scheme is to support Scheduled Tribes children studying in classes  $IX^{th}$  and  $X^{th}$  so that the incidence of dropout, especially in transition from elementary to secondary stage is minimized, and ST students can have a better chance of progressing to the post matric stage of education.

## Eligibility of the Scheme is as under:

- 1. Student should belong to Scheduled Tribe Community.
- 2. Her/ His Parents/ Guardians income should not exceed Rs. 2.50 lakh per annum.
- 3. She/ He should not be availing any other centrally-funded Pre Matric Scholarship.
- 4. She/ he should be a regular, full time student studying in a Government School or in a school recognized by Govt. or a Central /State Board of secondary Education.
- 5. Scholarship for studying in any class will be available for only one year. If a student has to repeat a class, she/he is not eligible to get scholarship for that class for a second (or subsequent) year.

The students of class IXth & Xth have to apply online on the National Scholarship Portal (NSP) in order to avail the scholarship. All above documents shall be scanned uploaded on the National Scholarship Portal. (Size of document less than 200KB in PDF/JPEG format)

The following documents are required to be uploaded on Portal.

#### For Fresh Students.

- 1. Income Certificate issued by competent authority for the year 2023-24.
- 2. Caste Certificate issued by competent authority.
- 3. Copy of Bank Pass Book seeded with Aadhar Card.

- 4. Marksheet (Previous Year)
- 5.Bonafide Certificate.

#### For Renewal Students.

- 1. Marksheet (Previous Year)
- 2 .Income Certificate issued by competent authority for the year 2023-24.
- 3. Bonafide Certificate.

Direct Benefit Transfer (DBT) Mission has issued following directions for compliance:

- (a). Aadhaar to be made mandatory for all applicants.
- (b). Aadhaar based bio-metric authentication and eKYC has been made mandatory from 2024-25.
- (c). All scholarship payments to be made using Aadhaar Payment Bridge (APB) system to ensure that payments are made only to the rightful beneficiary. Students have to seed their bank account with their aadhaar number so that they can receive the scholarship benefit in their bank account. Bank details will no longer be captured on the NSP portal.
- (d). State Nodal Officer/District Nodal Officer/Head of Institute/Institute Nodal Officer has to perform eKYC (bio-metric /face-auth) to verify applications from their NSP logins.
- (e). All Institute Nodal Officer (INO) are requested to refer New Guidelines of Pre Matric Scholarship (Centrally Sponsored Scheme) issued by Ministry of Tribal Affairs, New Delhi.

## The above conditions will be applicable for both fresh and renewal.

In renewal also, student should submit their application after completing their OTP based eKYC. Applications will not be submitted without Aadhaar based eKYC.

Further, NSP has introduced face-authentication from the academic year 2024-25. The following points are conveyed for compliance on the National Scholarship Portal.

- The Portal is open for One Time Registration (OTR) for students.
- One Time Registration (OTR) is a unique number allotted to the student and is applicable for entire academic career on National Scholarship Portal.
- OTR is required to apply for the scholarships on National Scholarship Portal from AY 2024-25.
  - OTR can be generated using Aadhaar/Aadhaar Enrollment number (EID)
  - The students who have applied on National Scholarship Portal in AY 2023-24 will be allotted the OTR/Reference number through the portal and intimated through SMS. For more details please.
  - NSP OTR App is available on Google Play Store.

 National Scholarship Portal for AY 2024-25 will be open soon. The date of the same will be informed accordingly.

Further, we may request all the Heads of Institute to submit the additional details in given annexure "A" on or before 15th July 2024 by mail (dir-tw.goa@nic.in) and hard copy to this Directorate.

The institute may bring the content of this circular to the notice of the student along with new guidelines to avail the benefit of scheme. The institute shall convey the date of opening &closing of the Portal to the students so that the students can apply before the last date.
