Sub:- Regarding Pre- Matric Scholarship Scheme for ST
Students studying in class Vth to Xth

Sir/Madam,

With reference to above cited subject matter, timeline for submission of application on Chief Minister's Scholarship Portal under Pre- Matric Scholarship Scheme for ST Students studying in class Vth to Xth has been extended (**Final Extension**) as under:

Last date for application submission	31 st December 2024
Last date for INO Level Verification	15 th January 2025
Last date for District Level Verification	31 st January 2025

Further, this is to inform you that for all eligible IXth and Xth standard applicants of scheduled Tribe Community whose annual family income is upto Rs. 2.50 lakh shall apply for the Centrally Sponsored Scheme of "Pre-Matric Scholarship for Needy Scheduled Tribe students studying in classes IXth & Xth" on the National Scholarship Portal, as well as Pre-Matric Scholarship Scheme for Scheduled Tribe students studying in class Vth to Xth on Chief Minister's Scholarship Portal. If applicant fails to apply on National Scholarship Portal and applies only for Pre-Matric Scholarship Scheme for Scheduled Tribe students studying in class Vth to Xth on Chief Minister's Scholarship Portal, the benefit will be limited to the difference of amount between Central Pre-matric Scholarship and State Pre-matric scholarship. If the student's family income limit is above Rs. 2.50 lakh upto 3.00 lakh then in such cases the student is eligible only for state scheme and the full amount of scholarship along with meritorious amount shall be paid to the student under State Pre-Matric Scholarship Scheme for Scheduled Tribe students studying in class Vth to Xth.

Hence, all the Heads of the Institutes /Nodal Officers are requested to assist and cooperate with the eligible students belongs to Scheduled Tribe Community

studying in class IXth and Xth for applying for said scheme on both online Portal i.e. National Scholarship and CM Scholarship Portal. Students studying in std Vth to VIIIth shall only apply on CM Scholarship Portal.

Also, it may be noted that, if any eligible ST student is left out from availing scholarship then the concerned Nodal Officer will be held responsible for the same.
