CIRCULAR

Sub:- "Pre Matric Scholarship Scheme for Scheduled Tribe students studying in class Vth to Xth."

The Directorate of Tribal Welfare is implementing the scheme namely:

"Pre Matric Scholarship Scheme for Scheduled Tribe students studying in class Vth to Xth".

The scheme aims to improve the educational status, and curb the tendency of drop-outs of Scheduled Tribes Students by way of providing financial assistance to the families of such students who are otherwise unable to send them to schools due to poverty.

Eligibility of the Scheme is as under:

1. The applicant shall be a bonafide resident of the State of Goa.
2. The applicant shall be a regular student of an institution.
3. The combined income of the parents / guardians of the applicant should not exceed Rs.3.00 lakhs per annum.
4. The applicant is not residing and receiving any maintenance grant in any institution under the Government or local bodies or private organizations receiving grants in aid from local or the Central Government.
5. The applicant will not be eligible to receive stipends or scholarships from any other source.
6. The applicant should belong to Scheduled Tribes.
7. The students shall not be eligible twice to receive the award of stipends in the same standard.

Required documents are as under: For Fresh Students

1. Income Certificate.
2. Caste Certificate issued by competent authority.
3. Copy of Bank Pass Book seeded with Aadhar Card.
4. Mark sheet.
5. Aadhar Card.
6. Photograph

Students applying first time for the Scheme shall be treated as fresh applicants and shall attach all required documents. Also Students who had applied during the academic year 2022-23 onwards shall be treated as renewal students

Required documents are as under: For Renewal Students

1. Income Certificate for the year 2023-24.
2. Mark sheet. (Previous academic year).
3. Copy of Bank Pass Book seeded with Aadhar Card.

Applications under Pre Matric Scholarships for the students belonging to Scheduled Tribe community studying in class Vth to Xth are invited Online on Chief Minister's Scholarship Portal <https://cmscholarship.goa.gov.in>

The details of opening and closing of Portal is as under:-

Opening of Portal	15 th July 2024
Last date for application submission	15 th October 2024
Last date for INO Level Verification	15 th November 2024
Last date for District Level Verification	15 th December 2024

All the Heads of the Institutes / Schools/ Nodal Officers are requested to assist and cooperate with the eligible Scheduled Tribe students for applying for said scheme on online Portal. Institute Nodal Officers appointed under the schemes are requested to verify each application promptly to avoid further difficulties.

The Nodal Officers shall verify and send the applications to this department on daily basis.

Also, it may be noted that, if any eligible ST student is left out from availing scholarship then the concerned Nodal Officer will be held responsible for the same.
