Whereas the Government has notified a Scheme Financial Assistance to ST students under "Gagan Bharari Shiksha Yojana".

And Whereas Government desires to amend Clause 4, Clause 7 and delete Clause 10 of the scheme Financial Assistance to ST students under "Gagan Bharari Shiksha Yojana" in public interest & Clause 6 was deleted earlier vide notified in Official Gazette, Series I No. 34 dated 19-11-2020.

Now therefore, Clause 4 & Clause 7 of the scheme Financial Assistance to ST students under "Gagan Bharari Shiksha Yojana" is amended to read as under:—

Clause 4. Eligibility Criteria— Student should belong to Scheduled Tribes community in State of Goa. Income of Parents/Guardians shall not exceed to Rs. 5.00 lakh per annum. Student should be regular, full time student studying in a recognized Institution/University. Scholarship for studying in any class will be available only for one year. If a student has to repeat a class, he/she shall not be eligible to get scholarship for second time in the same class.

Clause 7. Mode of application—Application in the prescribed form for availing Gagan Bharari Shiksha Yojana along with following documents is to be submitted to the Directorate of Tribal Welfare, through the Head of the Educational Institution.

- 1) Passport Size Photograph.
- Attested copies of mark sheet/Passing Certificate of the exam passed in the Academic year.
- Attested copy of Income Certificate issued by competent authority for the year.
- Attested copy of Schedule Tribes Certificate issued by competent authority.
- 5) Attested copies of hostel receipt.
- 6) Attested copy of Bank Pass Book.
- 7) Attested copy of Adhaar Card.

## Clause 10. Deleted

This amendment shall come into force from the date of Notification in the Official Gazette.
