Background

Ministry of Tribal Affairs has been implementing the scheme 'Special Central Assistance to Tribal Sub-Plan (SCA to TSP)', initiated in 1977-78. After amalgamation of Plan and Non-Plan, the scheme was known as 'Special Central Assistance to Tribal Sub-Scheme (SCA to TSS)' since 2017. Earlier the coverage of the scheme was limited to 23 States (including J&K), while the States of Arunachal Pradesh, Meghalaya, Mizoram and Nagaland were not covered. During the year 2017-18, it was decided by the Ministry to extend the benefit of the scheme to these States as well in the larger interest of the STs. The scheme of Special Central Assistance to Tribal Sub-Scheme (SCA to TSS) has been providing funds to the State Governments having notified STs for development and welfare of tribal people to bridge the gaps in sectors like education, health, agriculture, skill development, employment-cum-income generation, etc. In order to improve basic services and facilities in villages with significant tribal population, it has been decided to transform the scheme, so that integrated village development programmes can be implemented in an outcome-oriented and time- bound manner. Accordingly, the existing scheme 'SCA to TSS' has been revamped as 'Pradhan Mantri Adi Adarsh Gram Yojana (PMAAGY)' to be implemented during the years 2021-22 to 2025-26.

2. Vision

The scheme 'Pradhan Mantri Adi Adarsh Gram Yojna (PMAAGY)' has the vision to transform the villages with significant tribal population into model villages (adarsh gram), having saturated basic services and adequate infrastructure, through convergence of government schemes, so as to enable the villagers to develop their potential for a meaningful contribution to the economy and society.

3. **Objectives:**

The main objective of this scheme is to achieve integrated socio-economic development of selected villages through convergence approach. It will include the following components.

- Preparing Village Development Plans, based on the needs, potential, and aspirations;
- Maximizing the coverage of individual / family benefit schemes of the Central / State ii. Governments;
- Improving the infrastructure in vital sectors like health, education, connectivity and iii. livelihood;

General Features of the Scheme 4.

Nature of the Scheme: The Scheme 'PMAAGY' is a Centrally Sponsored Scheme with 100% Grant from Government of India (GoI). Plo

- ii. Coverage of the Scheme: All States and UTs having notified ST population will be covered under the Scheme. A total of 36,428 villages having at least 50 % ST population and 500 ST persons have been identified to be covered in the first phase of five years during 2021-22 to 2025-26 (Annexure 1).
- iii. **Provision of fund under the Scheme:** A sum of Rs. 20.38 lakh per village will be provided as 'gap-filling' fund for approved activities including administrative expenses.
- iv. **Implementing Agency:** Implementation of the scheme will be done through State / UT Government administration.
- v. **Scope of the Scheme:** The scheme will support creation and improvement of infrastructure facilities in identified villages in priority sectors like health and nutrition, drinking water and sanitation, education, road and telecom / mobile connectivity.
- vi. Village Development Plans: The VDP will also aim at following inclusions,
 - (a) Skill Development plans
 - (b) Village Development Plans with Community Forest Development
 - (c) Integration of Van Dhan Programme
 - (d) Conservation of perennial river resources and water bodies originating from forests
- vii. **Technical Support:** Project Monitoring Unit (PMU) will be set up at Central and State level to provide technical resource support.
- viii. Database Management: Dedicated MIS will be developed to monitor the progress of work.
- ix. **Approval Mechanism:** Approval of annual plan under the scheme will be given by the Ministry of Tribal Affairs, following the procedure as stipulated under the scheme guidelines.
- x. Administrative Expenses: An amount of 2% of the allocated budget available under the scheme will be utilized for administration and monitoring systems including providing technical support system and personnel and capacity building programs.

5. Selection of Villages

As this scheme is being launched during the celebration of 75 years of Independence (Azadi Ka Amrit Mahotsav), it is planned to select about 7500 villages with significant tribal population every year for achieving integrated development.

Villages with at least 500 ST persons and 50% ST population have been identified, based on 20 census. State/UT -wise a total number of 36,428 such villages is given in **Annexure 1**.

- 5.2 All these identified villages will be covered in 5 years; therefore, about one-fifth of total villages will be selected every year.
- 5.3 Selection from among the identified villages will be done by the Ministry of Tribal Affairs. As far as feasible, villages in the selected district will be taken together.
- 5.4 Release of grants during a financial year will be in accordance with the number of villages approved by the Ministry of Tribal Affairs for the State/UT.
- 5.5 Depending on the progress achieved both in physical and financial terms, as also subject to submission of Utilization Certificates, actual release of grants or sanction of number of villages in a particular financial year may be varied by the Ministry of Tribal Affairs, subject to the over-all limit of the number of identified villages in that State/UT, and subject to availability of budgetary grants.

6. Release of Grant

- 6.1 In the first year of this new scheme, entire available grant will be released in one instalment, to States/UTs in proportion of the number of total villages, so as to facilitate starting of this new scheme.
- 6.2 In the second and subsequent financial years, Grants will be released in two instalments. The first instalment upto 50% of the admissible grant will be released after selection of the villages. The balance admissible central assistance will be released after approval of the Village Development Plans by the State/UT and approval of the State/UT Plans by the Project Appraisal Committee in the Ministry of Tribal Affairs.
- Release of the second instalment in a year will also be subject to adjustment of pending Utilization Certificate under the PMAAGY, including any previous pendency of UCs in the earlier SCA to TSS scheme.
- In case any State/UT does not submit the requisite action plans or the due UCs, by the end of the third quarter of a financial year, or by the end of any extended time allowed by the Ministry of Tribal Affairs, the resultant saving may be allowed to be utilised by other State/UT, depending on their performance and readiness.
- 6.5 If a State/UT cannot utilize its annual allocation in a particular year as in 6.4 above, it will not be entitled to claim such unutilised allocation in any subsequent year as a matter of right. Approved or committed activities though will be permitted to be carried forward, with either fresh allocation during the next year or through the own resources of the State/UT.
- 6.6 Fund-flow shall have to follow the procedure prescribed under Public Financial Management System (PFMS), GFR and other guidelines like having a State Nodal Agency (SNA) and other stipulations made by the Department of Expenditure, Ministry of Finance, Government of India from time to time. The funds will be released to State Tribal/Social Welfare

Department, which in turn would release to the District agency in proportion to the number of villages selected in that district.

- 6.7 It is estimated that Rs. 20.38 lakh per village will be provided from the grants of the Ministry of Tribal Affairs, Government of India.
- 6.8 The States/UTs will be encouraged to achieve convergence from other schemes of the Central or State/UT government for enhancing the financial resources to achieve the objectives of the Village Development Plans.
- 6.9 The States/UTs will also be free to generate resources through public-private partnerships, CSR funds, DMF etc. for achieving the objectives of integrated tribal village development.
- 6.10 As far as feasible, the Village Development Plan will make a clear mention of the works to be implemented through the funds being released by the Ministry of Tribal Affairs, up to about Rs. 20.38 lakh for a selected village. The district level committee may combine the action plans of two or more villages, subject to concurrence of the respective Gram Sabhas, if facilities for common benefits are to be planned. Financial utilization of grants released by the Ministry should be identifiable in terms of physical achievement. Specific physical progress achieved through dedicated funding under the PMAAGY will facilitate smooth and continuous release of funds to the State/UT.

7. Preparation and Approval of Village Development Plan:

Preparing a plan based on the needs and resources will be a key factor in successful implementation.

- 7.1 Village Development Plan (VDP) should be prepared in active consultation with the villagers, and be adopted by the Gram Sabha/ Panchayat/Village Council.
- 7.2 Every identified and approved village will prepare VDP, with particular care to incorporate basic infrastructure, such as
 - Road connectivity (Internal and Inter-village /block)
 - Telecom connectivity (Mobile /internet)
 - School
 - Anganwadi Centres
 - Health Sub-Centre
 - Drinking water facility
 - Drainage and solid waste management

The VDP may also incorporate skill development, community forest development, integration with Van Dhan Yojana and conservation of water resources.

- 7.3 Villages in less developed areas or Aspirational Districts should be given priority.
- 7.4 District Level Committee headed by the District Magistrate/ Chief Executive Officer, Zilla Panchayat/ Project Officer, Integrated Tribal Development Programme (ITDP)/Integrated Tribal Development Agency (ITDA), as prescribed by the State/UT will give approval to the Village Development Plans as per the scheme guidelines. District Level Committee will make all feasible efforts to achieve convergence among government schemes in the identified villages.
- 7.5 All VDPs for a particular year will be combined in the State/UT PMAAGY Action Plan for that year and will need to be recommended by the State Level Committee under the Chief Secretary/Development Commissioner. The State/UT Level Committee, while examining the VDPs approved by the District Level Committee, will pay special attention to the main objective of achieving convergence with STC/TSP components of other Central /State level schemes or projects.
- 7.6 The State/UT Action Plan of PMAAGY, as recommended by the State/UT Level Committee will be submitted to the Ministry of Tribal Affairs for final appraisal and approval by the Project Appraisal Committee.

8. Nodal Department

The Department dealing with matters of tribal welfare and development at the State/UT level will be the State Nodal Department for this scheme. The Principal Secretary /Secretary of the Department will supervise the implementation of PMAAGY. The Nodal Department will ensure the following.

- 8.1 Village Development Plans (VDPs) under PMAAGY are prepared in respect of villages approved by the Ministry of Tribal Affairs as per the prescribed procedure and formats.
- 8.2 VDPs are based on the needs and potential of the respective villages / areas, and are reasonable and feasible, with clarity about outcome indicators to be achieved; (Formats for progress reports in **Annexure 3&4**)
- 8.3 Grants received from the Ministry of Tribal Affairs for implementation of PMAAGY are released through Public Financial Management System (PFMS) in the prescribed manner, and proper accounting of expenditure is maintained along with physical progress reports;
- As far as feasible, convergence with other government scheme is achieved in formulation and implementation of VDPs, particularly of STC / TSP components of Central / State schemes, as illustrated in **Annexure 5&6**;
- 8.5 Updating the progress on MIS / Portal;
- 8.6 Utilization Certificates (UCs) as per GFR are submitted in time:

- Optimal utilization of supporting resources such as District Mineral Funds (DMF), 8.7 Finance Commission Grants etc.
- 8.8 Implementation of projects under PMAAGY must follow the approved norms and guidelines of procurement, based on transparency, economy and efficiency;
- 8.9 Implementation of projects under convergence schemes will follow the guidelines of the respective schemes.

9. Composition of District Level Committee(DLC)

- i. District Magistrate / CEO, Zilla Panchayat /Project Officer, ITDP - Chairperson
- ii. - District Officers of the Departments of Agriculture, Irrigation, Forest, Revenue, Health, Education, Lead Bank, Telecommunication, Rural Development Engineering representatives of TRIFED and scientists of Krishi Vigyan Kendras (KVK) as Members.
- iii. Members as co-opted by the District Level Committee.
- iv. Before examining the VDPs, the Chairperson, District Level Committee will make due consultations with people's representatives including Hon'ble Members of Parliament/ State Legislature representing the district.

10. Composition of State/UT Level Committee

- i. Chief Secretary / Development Commissioner- Chairperson
- ii. Principal Secretary / Secretary (In-charge of Tribal Development) -Member Secretary
- iii. Secretaries or Heads of Department of all concerned administrative departments, including Rural Development - Members

11. Composition of Project Appraisal Committee at Ministry

Proposals received from the State/UT Government(s) will be placed before the PAC for appraisal and approval. Project Appraisal Committee (PAC) in Ministry of Tribal Affairs (MoTA) will consist of:

Chairperson, PAC may co-opt any other officer or expert to provide suggestions relating to any matter under consideration of PAC.

12. Technical Resource Support for Adarsh Gram Villages

- i. The scheme envisages not only creation of infrastructure facilities based on gaps in the identified villages but also facilitating individual/family-based entitlements; therefore, efficient project monitoring mechanism will be established with necessary technical support and manpower at State and District level for preparation of Village Development Plans, including creation of database in respect of family based entitlements and identification of infrastructural gaps in identified villages, and to ensure convergence of funds under relevant schemes of Central and State STC/TSP.
- ii. At the national level, there will be a Project Monitoring Unit in the Ministry of Tribal Affairs to provide technical resource support for execution of the Scheme in coordination with the Central Ministries, State Government, District Administration, ITDP / ITDA etc.
- iii. Similarly, at the State/UT level, Department in-charge of Tribal Development will have a Project Monitoring Unit for providing technical resource support for implementation of the Scheme in coordination with District Level Committee / ITDP / ITDA / MADA Clusters / Gram Panchayats, etc. Necessary support systems may also be provided at the District/Division level based on the need.
- iv. Tribal Research Institutes(TRIs), National/State Institute of Rural Development, Government Orgnisation/Society, Central/State PSU, or reputed NGO/OBO can

be engaged following transparent processes for providing technical resource support, training and capacity building, awareness generation, monitoring, etc. State/UT Government will take required action in this regard in consultation with the Ministry of Tribal Affairs, Government of India.

13. Training and Capacity Building

Convergent implementation of the ongoing Central and State Plan Schemes in tribal villages will require identification of the village needs, systematic listing of all relevant Central & State STC/TSP Schemes and preparation as well as successful implementation of the VDPs under PMAAGY. The State/UT Governments will therefore take up necessary training and capacity building of the Scheme functionaries at all levels with the help of related Departments providing technical resource support.

14. Awareness Generation and Publicity

Awareness generation through Information, Education and Communication (IEC) in the selected villages and in the blocks and districts concerned should be undertaken by the State Government /UT Administration. Besides, social messages on aspects relating to various socio-economic indicators of hygiene, health, nutrition etc. can be disseminated.

15. Transparency and Accountability

- 15.1 The States/UTs shall make their nodal departments responsible for ensuring transparency and accountability at all levels in the implementation of PMAAGY and for updating information relating to schemes/programmes, allocation, expenditure, physical achievements and utilisation certificates in respect of VDPs.
- 15.2 State Nodal Department shall co-ordinate progress of various schemes / programmes and design a comprehensive monitoring framework with well-defined indicators covering fund allocation, release and expenditure, service delivery standards as well as outcomes in consultation with MoTA.
- 15.3 The States/UTs shall get integrated with the centralized web enabled MIS with software engineered data to make all information transparently available regarding release of funds and expenditure against each scheme/programme, physical progress, etc.
- 15.4 The Nodal Department shall ensure follow up of the schemes implemented and maintenance of proper records on assets created under VDP.

- 15.5 State Nodal Department shall ensure regular review of progress under Chief Secretary/ Development Commissioner.
- 15.6 The Ministry of Tribal Affairs, Government of India will carry out concurrent monitoring through physical and financial reports and visits by officers of the Ministry to review the implementation status. The scheme will be evaluated by MoTA before the end of 2025-26.
- 15.7 The States/UTs will conduct Social Audit Programme with the involvement of elected representatives, beneficiaries and reputed voluntary organizations in a transparent and effective manner.

16. State and National-level Awards for Best Performing Villages

Up to three best performing villages from every participating State/UT will be selected on the basis of defined parameters by a selection committee constituted by MoTA. Selected villages will be given an award of Rs. 5 lakh each. Further, three amongst these villages will be selected for National Awards of Rs. 10 lakh each. Recommendation of the State/UT Government will be needed for consideration of these awards.

The criteria for award of Adarsh Gram will be multi-dimensional, encompassing the following attributes:

- (i) 100% enrolment of children in schools
- (ii) existence of harmonious grievance redressal mechanism in villages
- (iii) optimal and sustainable utilization of common resources
- (iv) villages that are ensuring conservation of their traditional identity and culture.
- (v) performance on vital health parameters including maternal & child health and vaccination.
- (vi) hygiene, cleanliness, and sanitation levels
- (vii) formulation and implementation of village development plans

17. Relaxation

Any necessary modification or relaxation of these guidelines will be done with the approval of the Hon'ble Minister for Tribal Affairs, Government of India.
