No. 1/13/2010-11/ADMN/TW

1. **Objective:** - The objective scheme "Kanya Dhan" is to promote education among the girl children of the Scheduled Tribe Communities and further to assist these weaker sections of the society.

2. **Target Group:** - All the girl children of the families notified as ST under Constitutional Order and whose annual income does not exceed Rs. 1,50,000/- per annum.

3. **Eligibility:** - (1) The girl child who has passed 10th Standard examination and gets admission in the 11th Standard of any stream (Science/Arts/Commerce/Vocational/ITI) is eligible under the scheme.

(2) Maximum 2 girls' children from each family are entitled to avail benefits under the scheme.

4. **Financial Assistance:** - An amount of Rs. 25,000/- will be provided by way of fixed deposit in the name of the girl child and the officer-nominated by the Government. This amount will be given to the beneficiaries only when she passes 12th Standard Board Examination or its equivalent examination on 3 attempts or within 2 years of first attempt whichever is earlier; failing which the amount sanctioned shall be forfeited and the same will be deposited in Government treasury. In case the beneficiary drops out, the money will be forfeited in favour of the Government of Goa.

5. **Mode of application:** - Application for assistance shall be submitted through the Principal of the Institution in which child is studying in XI Standard in the prescribed form, to the Director of Tribal Welfare.

Read: "VIDYA LAXMI".

Whereas the Government has notified Scheme Vidya Laxmi vide Notification No. 1/13/2010-11/ADMN/TW dated 07-01-2011, Amended Notification No. DTW/5/KAN-DHAN/Scheme/9/Amendment/2014-15/8265 published in Official Gazette, Series I No. 44 dated 29-01-2015 and Notification No. DTW/5/Vidya-Laxmi/Scheme/9/Amendment/2018-19/252 dated 19-04-2018.

And whereas the Government desires to amend the Scheme Vidya Laxmi at clause 3, to omit the sub-clause 2 of clause 3 and to add clause 6.

Therefore clause 3 of the above scheme is amended and may be read as under:

3. *Eligibility.*— The girl child who has passed 10th standard examination and gets admission in the 11th Standard of any stream (Science/Arts/Commerce/Vocational/ITI) is eligible under the scheme.

In case student/beneficiary changes the stream or Institute after making FD of sanctioned amount then she shall be eligible for release of FD as per the terms and conditions mentioned in the clause 4 of the scheme.

Now, the clause 6 is proposed to add under "Vidya Laxmi" scheme is as under:

Clause 6

Sanctioning Authority/Officer Nominated:

(a) Director of Tribal Welfare shall sanction the amount of benefit under the scheme.

(b) Director of Tribal Welfare shall be the Officer Nominated under the clause 4 of this scheme.

All other clauses in the above mentioned scheme remains unchanged.

This amendment shall come in to force with effect from academic year 2020-2021.
